What is Portsmouth Festivities?

Portsmouth Festivities is an annual 10-day arts, culture and heritage festival, which aims to provide a high quality programme of citywide performances and events which capture imaginations, celebrate diversity and reflect on the heritage value of Portsmouth.

Every year, we...

- champion the very best of Portsmouth
- · help to shape the provision of accessible cultural experiences for all
- provide platforms for different and other audiences
- grow and develop extending our reach, reputation and impact

Next year's Portsmouth Festivities will take place between Friday 14 and Sunday 23 June 2019.

What is the Festival Community Programme?

We are motivated by a desire to connect with local cultural and creative individuals and organisations, exchanging ideas, energy and resources to promote the imaginative life and wider profile of the city. Our Festival Community Programme means that you can apply to put on an event as part of the Festivities.

We are here to provide you with the support and exposure necessary to help make your event a success.

Bringing an event to the Portsmouth Festivities will mean the chance to showcase it to a wide and diverse audience, an audience including producers, promoters, journalists and fellow artists.

Portsmouth Festivities is a registered charity, and we work closely with our team of Creative Partners to help make decisions regarding creative programming for the Festival Community Programme.

Things to consider

The theme for 2019 is **TWENTY.** It is the 20th anniversary of Portsmouth Festivities so would strongly welcome applications with a relevance to this theme.

By submitting an application form for inclusion in the Portsmouth Festivities 2019 Community Programme, you agree to manage all aspects of your event, including all costs. We are always happy to give advice in staffing, venue procurement and marketing.

On application it is necessary to share with us examples of past work, images or reviews of work.

The Portsmouth Festivities is simply providing a platform to platform your event to a wider audience. Beyond this, it cannot be held liable for any aspect of your event, including its sales, planning and delivery.

Before submitting your event, we suggest you carefully consider the following:

Securing a suitable event venue Performance Rules and Regulations PRS for Music Securing the necessary public liability insurance Making arrangements for selling tickets on the door Obtaining any necessary Clearing Rights & Copyright Photographic Performance Limited Declaring any income to the relevant authorities



Please note that all necessary performance and licensing permissions must be in place by Friday 11 January 2019, including Young People's licence for those under the age of 16 before 14 June 2019. Otherwise, your event will not be included in the Festival programme. On some occasions, we may request written proof that the necessary permissions have been obtained.

Should your application be successful you will need to meet with one of the Festivities team to discuss your event in more detail.

How to apply

The application form is available online at www.portsmouthfestivities.co.uk from 28 September 2018.

To submit the form, you must complete all the necessary information and send it back to us on/before midday December 3 2018.

Once submitted, your form will be processed by the Festivities team.

There is a selection process. The Festival Community Programme is curated by the Festivities team and our 13 Creative Partners from across the City.

If your application is successful, we will notify you by December 14 2018.

We will use the contact details supplied on your completed form. Make sure you know who is registering your event.

Deadlines - how it works if you are successful

You will be sent a Pro Forma to complete and return, in its original format, with which we will ask you to send us up to three high res images and up to 40 words of copy on/before **Friday 11 January 2019**. It is vital that your copy and image/s are exciting and interesting.

Only fully completed forms submitted on/before **January 11 2019** will be considered for inclusion in the Festivities brochure. This is owing to our programme brochure print deadline.

Completed forms submitted after this deadline will not be considered for inclusion in the brochure.

Please note that any submissions (or any changes or cancellations applying to existing submissions) made after the Programme goes to print are subsequently the responsibility of the representative of the company, organisation or individual who signed the 'Festival Community Programme 2019 Application Form'.

Proofing

We will format your entry in the Festivities programme for print and web, according to the information you provided in the application form. It is therefore essential that all information you supply is accurate.

A proof of your programme entry will be emailed to your event contact(s) in early February 2019.

After receiving your entry you must contact us straight away with any changes to dates/venues etc. If however Festivities have gone to print, Festivities will only be able to make online changes to the programme and therefore organisations could be subject to printing charges.



Marketing

In return for us agreeing to platform your event in the Portsmouth Festivities programme, we respectfully request that you include the Portsmouth Festivities logo in all flyers and posters you may generate to further promote your event. This will be sent to you.

We also ask that you mention the Portsmouth Festivities in any press releases, programmes or other copy content you may generate for online/printed publication. Do tag Portsmouth Festivities in posts on Facebook, Twitter and Instagram for the team to re-share your details.

We sometimes have professional photographers covering our events. Please make sure that if participants under the age of 18 are involved the team know of any permission queries. We do share pictures with our creative partners and any taken by our photographers are sole property of the Festivities. Any pictures used with permission from the Festivities must credit Portsmouth Festivities when used.

Box Office

In order to make the booking process as simple as possible for Festivities audiences, all events within the Portsmouth Festivities programme must be available for booking via our central Portsmouth Festivities Box Office at Kings Theatre, Portsmouth. We are happy to sell all of your tickets, though you must allocate a **minimum of 50%** of your total event capacity for sale via the Portsmouth Festivities Box Office.

Any tickets sold through the Portsmouth Festivities Box Office, will be subject to a **25% commission fee** which will be deducted from your payout.

All takings you receive via your own box office/on door sales will not be subject to this fee.

Please note that we calculate the commission on your gross sales (i.e. before tax is deducted) and it is then your responsibility to settle any PRS, VAT or other tax liabilities for your sales as appropriate for your individual set-up. This does not count if it is a free ticketed event.

In early July 2019, Portsmouth Festivities will send you a full report detailing your box office takings, including full ticket sales, deductions and calculations of final figures.

We will ask you to invoice us for the final net amount (i.e. gross sales, minus 25% commission) and process payments to the account details you provide on your invoice.

Please be advised that all Box Office enquiries are to go direct to Festivities and not with the Kings Theatre direct.
